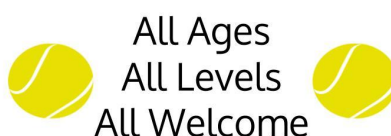

PATC Court Contract Time Rules 2024-2025:

1. **Definition** - When purchasing contract time, you have the right to use the court during that time every week, or as detailed in the PATC 2024-2025 Contract Dates Document. Rather than booking a court every week, contract time ensures the court will be available for you, even when the weather becomes colder and these courts are more desirable. Depending on the time of day, court time can become cheaper when purchasing it through contract time.
2. **Purchasing Additional Court Time Rates** - After purchasing seasonal court time, you become eligible for discounted weekly court time. The rates are as follows for Weekdays and Weekends: 7am-9am: \$40, 9am-4pm: \$45, 4pm-10pm: \$50. If your booking overlaps between price ranges, the higher amount will be used.
3. **Payment** - All deposits are to be received upon booking your court time. All final payments (the balance left after the deposit) are to be received on or before your first scheduled day of contract time; no exceptions. If you or your court fail to present adequate funds by the dates previously stated, you forfeit the court and PATC has the right to sell your court time.
4. **No Monetary Refunds** - All contract time is non-refundable. In the event of bad weather and the club being closed, PATC will issue court credit for your scheduled time. You may use this credit on or before the last day of your contract time, no exceptions. In the event of a tournament, league, or maintenance and your court becomes unavailable, you will be issued credit for the time to be used before the last day of your contract time. You will be notified in advance, should your court become unavailable.
5. **Makeups** - If you cannot use your court, PATC will try to sell the court time. If PATC successfully sells the time, you will receive credit that you may use before the last scheduled day of your contract. Otherwise, you forfeit the court time; no exceptions. For a complete list of contract time dates, see the "PATC Contract Time Dates" Document.
6. **Checking In** - PATC requests that all contract time players check in at the front desk before entering the courts to receive their court assignment. PATC cannot guarantee that each week the court will remain the same; we guarantee only that the court will be available to you. Players should leave promptly and courteously at the end of their scheduled time.
